Subject: Invitation to contribute to the Journal Colombian
Institute of Tax Law No. 78

Dear Sirs,

The journal of the Colombian Institute of Tax Law published since 1965 and on a biannual basis, announces to the national and international academic community the opening of the call for receiving research articles, reflection, review and topical notes in all subjects of tax law, customs law and foreign trade as well as in other economic, financial and accounting areas about this related.

The journal main content is composed of research articles, reflection and revision, ICDT concepts issued to the Constitutional Court on standards that have been sued, notes on some of the roundtables conducted, book reviews and topical notes.

After considering the concept of peer reviewers and in accordance with the regulations of the journal, the Editorial Committee selects the articles to be included in each publication, which must meet the following conditions:

1. The articles must address tax issues, customs law and foreign trade, which may be approached from the legal, economic, accounting, financial or sociological standpoint.
2. The articles must be delivered no later than August 15th, 2018 to the journal email:
c.investigacion@icdt.org.co, or by mail in digital formats (memory stick or cd) to the ICDT Administrative Headquarters (Calle 75 # 8-29, Bogota, Colombia).
3. The articles must contain an academic contribution under any of the following modalities:
 - i) Research and innovation article
 - ii) Actuality notes
4. Each article should have a maximum length of 30 letter-size pages in font Arial 11, single space, Word format and 3 cm margins to be considered in the selection process.
5. Each participant must fully respect copyright, differentiate his/her personal opinions from those of consulted authors and include bibliographic references using **The**

Bluebook: a uniform system of citation as a citation guide.

6. Each author is responsible for the content, composition and spelling of the article and must guarantee its proper presentation.
7. The author's name must be accompanied by its institutional affiliation and a brief footnote (2 lines maximum) with a summary of his/her profession, undergraduate and graduate (university) studies, current occupation, phone number, postal code and email address, to maintain communication with the editor.
8. The article must contain the following parts:
 - Title (in English and Spanish).
 - Abstract of 10 lines maximum (in English and Spanish).
 - Keywords, 12 keywords maximum (in English and Spanish).
 - Summary or Table of contents.
 - Introduction.
 - Conclusions or recommendations.
 - Bibliography and footnotes according to **The Bluebook**.

ICDT will provide assistance with abstracts and keywords in Spanish in case the author is unable to provide them.

9. By accepting to submit a contribution, each author declares that the article is of his/hers authorship and has never been published. The author agrees to transfer the property rights derived from its publication, which is deemed to be effective upon the delivery of the article without prejudice to the express declaration that it shall present to the Institute to that effect.
10. In furtherance of the policy established by the Editorial Committee of the ICDT journal and following the indexing criteria of scientific journals, all of the articles will undergo an anonymous and confidential arbitration or peer review process, which will be carried out by peer reviewers. Based on this arbitration or review, the Editorial Committee will select the material that will be published and communicate

to the author the observations of the peer reviewers.

11. The authors must send their CV, along with the own article.
12. The authors must have a Google scholar account (requirement for indexed magazine) and must send the user account in their cv.

Deadline: August 15th 2018

We look forward to your participation and increasing acceptance in order that the journal may continue to be a mechanism of reflection, exchange of opinions and dissemination of knowledge on issues of interest that bring us together.
